- Review Digital Service Squad contract for Megan McDonald.

- Municipal Report Jim McManaman and Matt Gilmer
 - Development Charges Study and Bylaw.
 - Jim M advised that Downtown still has one year of Development Charges exemption. Bylaw will be reviewed in one year. Affordable housing developments will be exempt from Development Charges.
 - Debbie asked about what is happening with areas in the Downtown that are not being developed. Jim M responded that there is not much that can be done in terms of forcing development to occur.
 - Debbie asked about status of courthouse on Water Street. Mayor advised that municipal staff are looking into possible options including applying for external funding.
 - o Community Improvement Plan.
 - Matt advised that \$50,000 will be available effective immediately with the deadline to apply October 31, 2019. The window to have any eligible work completed is one year ending September 1, 2020. The program is exactly the same as the previous one.
 - The program will be reviewed by the Community and Economic Development Advisory Committee and they will make a recommendation to council on how to improve effectiveness for 2020.
